



**Pumps, Pearls, and Purses in Paradise

NOW THEREFORE, in consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and adequacy of which is hereby severally acknowledged, JLSF and Exhibitor hereby agree as follows:

- I. Exhibitor hereby agrees to rent \_\_\_\_\_ booth(s) at the Event for the display of merchandise, and agrees to pay to JLSF the sum of the per 8’x8’ booth space the sum of \$200.00.
- II. Exhibitor hereby agrees to donate one gift certificate with a minimum value of \$20.00 to the event. Item should be received by Monday, January 5, 2010.
- III. The fees for the booth space shall be paid on or before December 10, 2009 to guarantee your booth space.
- IV. Booth set up may **begin at 2:00pm** on the day of the Event and **must be finished with set-up by 4:30pm** the day of the Event. All merchandise must be removed immediately following the Event, and no later than 11:00pm the night of the Event. You are responsible to provide your own lighting and extension cords for your display.
- V. Exhibitor shall be responsible for the safe storage of all merchandise. JLSF shall not be responsible for the storage or transportation of any merchandise, or for damage to merchandise for any reason.
- VI. JLSF is not and shall not be responsible for any liability of any kind arising in any way in connection with the operation of the booth, or any actions of the Exhibitor’s employee or agents, and the Exhibitor hereby releases JLSF and its members, officers, directors and agents as well as the Ramkota Hotels and members, officers, directors and agents from any and all liability for any loss or damage of any kind, including but not limited to personal injury, loss or theft of or damage to personal property, or arising out of the operation or use of the booth by the Exhibitor. Exhibitor agrees to indemnify JLSF and its members, officers, directors and agents from any and all liability, claims, actions, suits, losses, damages, costs and reasonable attorney fees, and other

expenses that may be incurred by JLSF or the Ramkota by reason of our in connection with Exhibitor's participation in and operation of the booth at the Event.
